6. Chittenden County Regional Planning Commission (CCPRC) Update from Anthony Micklus

Regional Planning's function is an organization that provides guidance to Vermont legislative groups who make policies. CCRPC has six major projects: clean water (repairing culverts, drainage, etc.), transportation (Milton's hourglass project, highway exit repairs and creation, etc.), Act 250 reform (housing/vacancy, providing town exemptions, etc.), broadband deployment, energy planning and climate change (electric cars, etc.), taxation (cannabis, etc.), TIF, and equity.

7. Greater Burlington Industrial Corporation (GBIC) Update

GBIC is interested in partnering with Milton. They are ready to hire 40 people. Seeking to conduct Northwestern Comprehensive Development Study.

8. Vermont Council on Rural Development (VCRC)

VCRC helps Milton develop into the kind of community Milton wants it to be (inclusive, diverse, etc.). The VCRC process takes about six months.

9. Commission Discussion - Social Events & Future Agenda Items

EDC is seeking member feedback on resuming EDC social events at local businesses. EDC is seeking input from committee members for agenda items.
