### Water/Wastewater Technician I Water/Wastewater Technician II

The Town of Milton is seeking to fill two (2) full time positions in our Water/Wastewater department, within Public Works, with openings for both a Technician I (“Tech I”) and a Technician II (“Tech II”)

Both roles perform duties in the operation and maintenance of the Municipal Water and Wastewater Treatment Facilities in order to provide an adequate supply of safe potable water for consumption, as well as a safe and effective Wastewater treatment System.

The Tech I role is an entry-level position, and the candidate should currently hold valid Grade 1-DM Wastewater Certification and a Class D water Distribution System Operator’s Certification, **or** participate in various training programs including assigned courses, correspondence courses, independent studies and on the job (“OJT”) programs designed to obtain these certifications within two (2) years of employment.

The Tech II role requires the a candidate with the ability to complete many water/wastewater department tasks on their own with minimal supervision and two (2) years of experience in water system operations and/or wastewater collection systems/Treatment plant operations; possession of Vermont Class 2-DM Pollution Abatement Facility Operator certification (preferred). Requires the possession of a Vermont Class D Water Distribution System Operator Certification within One (1) year of employment or promotion.

Starting salary range for the Technician I is \$20.00 – \$23.00 per hour and the Technician II is \$24.00 – \$28.00 per hour, depending on experience and qualifications. These are AFSCME union-track positions.
