

PURPOSE SELECTBOARD ACTION

THE ISSUE(S)

Amanda Pitts stated North Country Saloon has received its certificate of compliance and Rick’s Grill is pending once it’s certificate of compliance is issued following dumpster screening put in place (zoning permit application put in today), will be eligible on June 2nd. Bartlett moved to approve the outdoor consumption permit for North Country Saloon and Rick’s Grill with Rick’s Grill having the condition that they come into compliance with the local zoning regulations. Second by Palasik. **Approved 3-1 (Nolan voted against).**
