PRESS RELEASE

February 1, 2012

The Milton Police Department has completed a 3-4 month investigation into the sale of illegal drugs in Milton. This investigation included (7) seven separate residential drug search warrants and multiple controlled drug buys into drug dealers by Police.

Based on the investigation and the search warrants, (12) twelve people were charged with drug crimes. Seized during the search warrant were prescription drugs, cocaine, and marijuana. Also seized was approximately \$17,000 in cash tied to suspected drug transactions and (4) collectible classic cars, as well as (2) brand new vehicles that were paid off in full.

These search warrants were executed after several controlled drug buys into certain drug dealers.



Rudolph Dumas (Age 18) of Milton: Charged with Felony and Misdemeanor Sale of Marijuana and Possession of Marijuana with Intent to Sell. Dumas was issued a citation to appear in Chittenden County Superior Court on March 1st, 2012.



Dustin Davis (Age 22) of Milton: Charged with felony Sale of Crack Cocaine and Possession of Cocaine with Intent to Sell. Davis was currently on a deferred sentence with Chittenden County Superior Court for a conviction in 2009 for Sale of Crack Cocaine. He was lodged at the Chittenden County Correctional Center on new the new charges.

Sale of Regulated Drugs: carries a penalty of up to 5 years in jail and/or a fine of \$25,000.

Sale of Crack Cocaine/Cocaine: carries a penalty of imprisoned not more than five years or fined not more than \$100,000.00, or both.

Possession of Marijuana: carries a penalty of imprisoned not more than six months or fined not more than \$500.00, or both.

Sale of Marijuana (Felony): carries a penalty of imprisonment of not more than not more than five years or fined not more than \$100,000.00, or both.
