PRESS RELEASE

During the week of January 20th, 2006 the Milton Police Department executed 4 search warrants in the Town of Milton. These search warrants were part of a 3 week investigation into sale of regulated drugs occurring in Milton. After conducting several controlled buys of regulated drugs the Milton Police Department obtained 4 separate search warrants for the 101-53 West Milton Road, 101-189 West Milton Road, 104 Bear Trap Road and 76 Main Street all in the Town of Milton.

Upon execution of the search warrant the following people were charged with the assigned criminal offenses.

Lance Edward Jarvis (23 yrs) of Milton was charged with Felony Sale of Regulated Drugs. *Sale of Regulated Drugs carries a penalty of not more than five years in jail or fined not more than \$25,000.*

Mark Cody Ryan (21 yrs) of Milton was charged with 3 counts of Felony Sale of Regulated Drugs, Possession of Marijuana and Regulated Drugs with intent to distribute and Possession of Cocaine. *Sale of Regulated Drugs carries a penalty of not more than five years in jail or fined not more than \$25,000. Possession of Cocaine carries a penalty of imprisoned not more than one year or fined not more than \$2,000.00, or both.*

Robby Allen Smith (26 yrs) of Milton was charged with Possession of Marijuana, Possession of Regulated Drugs, Possession of Hashish, Cultivation of Marijuana and Felony Accessory to Sale of Regulated Drugs. *Cultivation of Marijuana carries a penalty of imprisoned not more than three years or fined not more than \$10,000.00, or both. Possession of Regulated Drugs carries a penalty of not more than one year in jail and/or fine of not more than \$2,000.00*

Nicole F. Pettinga (22 yrs) of Milton was charged with 3 counts of Possession of Regulated Drugs. *Possession of Regulated Drugs carries a penalty of not more than one year in jail and/or fine of not more than \$2,000.00*

Thomas C. Patterson (23 yrs) of Milton was charged with 4 counts Possession of Regulated Drugs and Possession of Marijuana. *Possession of Regulated Drugs carries a penalty of not more than one year in jail and/or fine of not more than \$2,000.00*

Joshua Adam Quintin (24 yrs) of Essex was charged with Possession of Cocaine and Possession of Regulated Drugs. *Possession of Cocaine carries a penalty of imprisoned not more than one year or fined not more than \$2,000.00, or both*

Derek J. Martin (20 yrs) of Milton was charged with Possession of Cocaine. *Possession of Cocaine carries a penalty of imprisoned not more than one year or fined not more than \$2,000.00, or both*

Pettinga, Patterson and Quintin were cited for March 2nd, 2006. Martin and Smith were cited for March 20th, 2006. Ryan was lodged at the Chittenden County Correctional Center.
