PRESS RELEASE

October 14, 2010

On October 8th, 2010 the Milton Police Department executed two drug search warrants simultaneously at 350 US Route 7 and 22-40 Forbes Road in the Town of Milton. These search warrants were executed after several controlled drug buys and an investigation into the sale of regulated and illicit drugs occurring in the Town of Milton.

Based on the search warrants and the investigation a total of (7) seven people were charged with drug crimes. Seized during the search warrant were prescription drugs, crack cocaine and marijuana. Also seized was approximately \$2000.00 in cash tied to suspected drug transactions.

This investigation follows a subsequent investigation that occurred by Milton Police in June of 2010 in which (19) nineteen people were arrested and charged with similar drug crimes.



Lance Jarvis (Age 27) of Milton, VT: Charged with (2) counts of Sale of Regulated Drugs (Felony). He was arraigned in Chittenden Superior Court on October 8th, 2010. This is Lance Jarvis's 2nd arrest for Sale of Regulated Drugs. He was arrested in January of 2006 for Sale of a Regulated Drug and convicted of such crime in August 2006.



Tammy Jarvis (Age 38) of Milton VT: Charged with Sale of Crack Cocaine (Felony). She was arraigned in Chittenden Superior Court on October 11th, 2010.

Donald Fuller (Age 34) of Milton VT: Charged with Conspiracy to sell Crack Cocaine (Felony). He was issued a citation to appear in Chittenden Superior Court on November 15th, 2010.



Javin Richardson (Age 21) of Bronx NY: Charged with False information to police and lodged on a fugitive from Justice Warrant originating in Pennsylvania . This warrant stems from original charges of Drugs Manufacture/Sale/Distribution or Possession with Intent to distribute.



Lawrence Brown (Age 38) of Greenfield MA: Charged with Possession of a Regulated Drug (Misdemeanor), Possession of Crack Cocaine and Conspiracy to Sell Crack Cocaine (Felony). He was Issued a citation to appear in Chittenden Superior Court on November 15th, 2010

Casey Metivier (Age 18) of Milton VT: Charged with Possession of a Regulated Drug (Suboxone) and Charged with Possession of Marijuana (Misdemeanor). She was issued a Citation to appear in Chittenden Superior Court on November 15th, 2010. Both charges are misdemeanors.



Christopher Labor (Age 24) of Milton VT: Possession of a Regulated Drug With Intent to Distribute and Conspiracy to Sell Crack Cocaine (Felony). He was issued a citation to appear in Chittenden Superior court on October 18th, 2010.

The **Sale of Cocaine** carries a penalty of not more than five years in jail or fined not more than \$100,000.00, or both.

The **Sale of Regulated Drugs** carries a penalty of not more than five years in jail or fined not more than \$25,000.00, or both.
