


PRESS RELEASE

On April 27th, 2006 and April 28th, 2006 the Milton Police Department with the help from the South Burlington Police Department, Burlington Police Department and Hinesburg Police Department executed (2) two drug search warrants. One search warrant was executed at 1185 Shelburne Road Unit #6B in South Burlington. The tenants of this apartment are Mark Vien (24) and Danielle McDonald (21). The second search warrant was executed at 13165 VT Route 116 in Hinesburg. This search warrant targeted William James Dun (22) and Savannah Vien (21). All four of the defendants are formerly of Milton.

The search warrants were part of extensive 3 month investigation into the sale of regulated drugs occurring in Milton and Chittenden County.

Upon execution of the search warrants the following people where charged with the designated criminal offenses.



Mark Vien (24) was charged with felony charges of Possession of Regulated Drugs with intent to distribute, 3 felony counts of Sale of Regulated Drugs, 4 misdemeanor counts of Violation of Pre-Trial Conditions of Release and a misdemeanor charge of Possession of Marijuana.

Sale of Regulated Drugs carries a penalty of up to five years in jail and/or a fined not more than \$25,000.00.

Possession of Regulated Drugs carries a penalty of not more than one year in jail and/or fine of not more than \$2,000.00



Danielle McDonald (21) was charged with a misdemeanor charge of Possession of Regulated Drugs, and a felony charge of Accessory to Sale of Regulated Drugs.

Possession of Regulated Drugs carries a penalty of not more than one year in jail and/or fine of not more than \$2,000.00

Accessory to Sale of Regulated Drugs carries a penalty of up to 5 years in jail and/or a fine of \$25,000.

William James Dunn (22) was charged with 3 felony counts of Sale of Regulated Drugs.

Sale of Regulated Drugs carries a penalty of up to five years in jail and/or a fined not more than \$25,000.00.



Savannah Vien (21) was charged with 2 felony counts of Sale of Regulated Drugs.

Sale of Regulated Drugs carries a penalty of up to five years in jail and/or a fined not more than \$25,000.00.

Mark Vien was lodged at the Chittenden County Correctional Center

Danielle McDonald was issued a citation to appear in Chittenden County Court on April 28th, 2006
